PLEASE NOTE - Alpine ski bindings have been adjusted for your weight, height, ability, and age and may not be readjusted by any other person except our rental technicians. High Mountain Sports Rentals closes 15 minutes after the lifts close. Please return your equipment after your last run. There is a \$15 late fee. There will be no refunds given for any reason.

In consideration of High Mountain Sports furnishing services and/or equipment to enable me to participate in alpine skiing, snowboarding, cross country skiing, ski boarding, or snowshoeing I agree as follows:

I fully understand and acknowledge that outdoor recreational activities have: (a) inherent risks, dangers and hazards and such exists in my use of High Mountain Sports equipment and my participation in High Mountain Sports activities; (b) my participation in such activities and/or use of such equipment may result in injury or illness including, but not limited to bodily injury, disease, strains, fractures, partial and/or total paralysis, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of High Mountain Sports; the negligence of the participants; the negligence of others, accidents, breaches of contract; the forces of nature or other causes. I understand that the binding system can not guarantee the user's safety. In downhill skiing, the binding system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release. In snowboarding, cross country skiing, snowshoeing and ski boarding the binding system will not ordinarily release during use; these bindings are not intended to release. Risks and dangers may arise from foreseeable or unforeseeable causes including, but not limited to, binding systems not releasing, equipment coming off and hitting the user, slipping and falling on wet, slippery, frozen, or moving surfaces, being hit by a snow vehicle, lightning or storms, being hit by another person on the slopes, hitting a mammade or natural obstruction, pulling or tearing a ligament or muscle, and such other risks, hazards and dangers that are integral to recreational activities and/or use of equipment. I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, or employees of High Mountain Sports, or by any other person.

I, on behalf of myself, my personal representatives and my heirs hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify High Mountain Sports, its owners, agents, officers, employees, and the equipment manufacturer from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of High Mountain Sports equipment or my participation in High Mountain Sports activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the equipment manufacturer and owners, agents, officers or employees of High Mountain Sports.

If the participant is under 18, I release and agree to indemnify and hold harmless the Releasees from any and all liabilities incident to my minor child's involvement or participation in these programs as provided above, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES, to the fullest extent permitted by law.

The Venue of any dispute that may arise out of this agreement or otherwise between the parties to which the High Mountain Sports or its agents is a party shall be either the District Court of Maryland in Garrett County or the Circuit Court of Maryland in Garrett County.

The renter assumes responsibility for any damages to the rented equipment and agrees to pay for repairs or full replacement value that may be necessary if lost, broken, damaged, or stolen at the discretion of High Mountain Sports.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE. IT IS MY INTENTION TO EXEMPT AND RELIEVE HIGH MOUNTAIN SPORTS FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE. I HAVE CONFIRMED THE BINDING RELEASE/RETENTION SETTINGS OR STANCE ON THIS EQUIPMENT CORRESPONDS TO THOSE STATED ON THIS FORM.
